

## **Terms in-Use of a Locker at the Chamber of Advocates**

### **TERMS AND CONDITIONS**

#### ***Locker Use***

The Member is being granted the use of the locker, which locker is to be used exclusively for the storage of one Toga. The Member is being granted the use of the locker for the period of time that the member is a paid-up member of the Chamber of Advocates, or until this agreement is terminated by either one of the parties for the reasons herein stipulated.

#### ***Assignment of Locker***

The Member shall not assign or transfer this agreement or any interest therein.

#### ***Compliance with regulations***

The Member agrees to comply with all rules, regulations and any special instructions that may be issued by the Chamber of Advocates concerning the Locker. The member agrees that the Chamber of Advocates may open and inspect the locker for the purpose of confirming the Member's compliance with this agreement. Every locker requires a one-time fee of €100 upon collection of key.

#### ***Termination of agreement***

The Member reserves the right to terminate this agreement whenever s/he deems fit. The Chamber of Advocates reserves the right to terminate this agreement and regain possession of the locker should the Member no longer remain a Member of the Chamber of Advocates, or should s/he fail to pay the annual membership subscription fee punctually.

On termination of this agreement, should the member fail to remove all his/her belongings from the locker, the Chamber of Advocates will take possession of any contents found within the locker and have them sent to the Member's last known office address at the Member's cost and expense.

***Waiver of responsibility***

It is mutually agreed that the Chamber of Advocates is not and will not be held responsible for the safety of any property contained in the locker assigned herein.

***Declaration***

I hereby acknowledge receipt of the key for locker number \_\_\_\_\_.

Although the key will be in my possession, I understand that it remains the property of the Chamber of Advocates. I agree not to release it to unauthorised persons or use it in a manner other than that for which it was issued. I further agree not to duplicate it.

I take full responsibility of loss or damage to the key during the time it is in my possession. I acknowledge that the Chamber of Advocates shall keep a copy of the key and that officers of the Chamber of Advocates may open and inspect the locker for the reasons stated above.

***Entire Agreement***

This constitutes the entire agreement between the parties. No modification or amendments of this agreement shall be valid unless in writing and signed by both parties.
