Appointment of Judges

The Minister for Justice and Reform of the Construction Sector is inviting applications for the appointment of two (2) Judges.

Applicants must fulfil the conditions set out in Articles 96 and 96B(2) of the Constitution of Malta. Nobody shall be qualified to be appointed Judge unless for a period of, or periods amounting in the aggregate to, not less than twelve years s/he has either practised as an advocate in Malta or served as a Magistrate in Malta or has partly so practised and partly so served.

Applications will be vetted by the Judicial Appointments Committee established by virtue of Article 96A of the Constitution.
